



Legislative Lobbyist Purchase Report

(Due not later than (15) business days after the purchase is made)

REPORTING THRESHOLD: Under IC 2-7-3-7, a lobbyist is required to file a report whenever the lobbyist pays more than \$100 to purchase goods or services from a member of the General Assembly, a candidate for election to the General Assembly, or such a member's or candidate's sole proprietorship or family business. However, a purchase report is not required if the purchase is made in the ordinary course of business and at a price that is available to the general public.

RELEVANT DEFINITIONS. The definitions of "candidate", "member", and "purchase" set forth in IC 2-7-1-1.3, IC 2-7-1-10.5, and IC 2-7-3-7(b), respectively, are relevant to this reporting requirement. The current text for each of those definitions is set forth on page 2 of this form.

WHERE TO FILE: A copy of the purchase report should be filed with the following:

1. the IN Lobby Registration Commission.
2. the member of, or candidate for election to, the General Assembly with respect to whom the purchase was made.
3. the Principal Clerk of the House of Representatives if the member or candidate is a member of, or candidate for election to, the House of Representatives.
4. the Secretary of the Senate if the member or candidate is a member of, or candidate for election to, the Senate.

Legislative Purchase Report
Definitions from IC 2-7

IC 2-7-1-1.3

Sec. 1.3. "Candidate" refers to a candidate for election to the general assembly.

IC 2-7-1-10.5

Sec. 10.5. "Member", except as used in section 8(5) of this chapter, IC 2-7-3-3(a), and IC 2-7-7-8, refers to a member of the general assembly.

IC 2-7-3-7(b)

Sec. 7(b). As used in this section, "purchase" refers to a purchase of goods or services for which the lobbyist paid more than one hundred dollars (\$100) from any of the following:

- (1) A member or candidate.
- (2) A member's or candidate's sole proprietorship.
- (3) A member's or candidate's family business, regardless of the manner of the family business's legal organization.
